Action on request by MIR Group, LLC, 5455 Sheridan Road, Kenosha, WI 53140 (Owner/Developer) for 1 Year Extension of Previously Approved Preliminary Plat of The Commons of Somers Subdivision, on Tax Parcel #80-4-222-151-0401, located in the NE ¼ of Section 15, T2N, R22E, Town of Somers, Kenosha County, WI (Located West side of STH 31-Green Bay Road-approximately .32 mi. south of CTH "E"-12th Street.)

Chairman Harbach read the request for action by the MIR group and also referred back to the minutes of November 12, 2012 by the Plan Commission and November 14, 2012 from the Kenosha Co Land Meeting.

Commissioner Lake asked if anyone was present from the MRI Group.

Fouad Saab, Architect was present representing the MIR Group and explained they were asking for an extension to keep the project going and preventing starting everything over.

8. Action on proposed conceptual revision to previously approved Preliminary Plat of The Commons of Somers Subdivision, MIR Group, LLC, 5455 Sheridan Road, Kenosha, WI 53140 (Owner/Developer), on Tax Parcel

#80-4-222-151-0401, located in the NE ¼ of Section 15, T2N, R22E, Town of Somers, Kenosha County, WI (Located West side of STH 31-Green Bay Road-approximately .32 mi. south of CTH "E"-12th Street.)

Chairman Harbach read the requested action on the new Concept Plan submitted from the MRI Group.

Fouad Saab, Representative for the MRI Group gave a presentation explaining the Project and the interest from University of Parkside pointing out changes from the original site plan.

Discussion followed regarding density of proposed apartments, roads, green space, traffic control, possible retail tenants, type of hotel (mid-scale, not to be a full service), parking, apartments and neighbors (Church & Bear Realty development).

Chairman Harbach asked for staff recommendation. William Morris, Town Administrator replied stating that staff supports the project and the impact that the apartments of the buildings will be minimal because of the slope of the grade. He also stated that in meeting with the University they stated people they have visiting from other countries have difficulty finding palatable housing throughout Kenosha to rent with a close proximity when visiting for 1 to 3 years.

Chairman Harbach called for a motion. Commissioner Donaubauer made the motion to approve and was seconded by Commissioner Mandernack. Motion carried 6-1 with Commissioner Lichter voting no.
