# TOWN OF SOMERS MINUTES of the REGULAR MEETING November 12, 2013

The Regular Meeting of the Somers Town Board was called to order at 7:00 p.m. by Chairman Ben Harbach at the Somers Town Hall, 7511 12<sup>TH</sup> Street.

#### **Citizen Comments**

Carl Kirkorian, 502 9th Place, commented on the Kenosha News not being at the meeting, Grego Sinnen's announcement about not running for election, the parking lot lights were on, and what Is going on with the fire chief position. Maciej Godlewski, 6205 45<sup>th</sup> St stated that he spoke to Mr. Kitzman and Mr. Kitzman was supposed to have some paper work ready, I show up to get it and it is not here. Once I get the paperwork, I will have more comments. Ron Grimes, 3145 72nd Avenue, has attended most of the work sessions, town employees are acting disrespectful to town supervisors and outside vendors, operational procedures should be reviewed as to who is responsible and who is supervising who and are they accountable to how employees are conducting themselves, a Life Quest billing form not being used since 2003, borrowing \$69,000. what are plans to get the fund balance and Moody's ratings back up, 9 sewer lifts and raw sewage being dumped into Lake Michigan, who is it reported to, impact fees are not being collected and used as intended, budgeting is not being done properly, the board does not know how to do it, overspending has depleted reserves, Fire Department costs are much higher than surrounding areas, a town employee with a salary and benefit package of \$107,000 and we are looking for work for him to do, nothing was done in the budget process to see how last year's levy of \$4.36 could be maintained. I will have more to say at the budget hearing.

#### **Supervisor's Comments**

Supervisor DeLuca – we have a stack of applications and the Fire Commission is going through them. Many of Mr. Grime's comments were addressed.

Supervisor Ress – he is growing a beard for charity for men's health issues; also addressed citizen's comments.

Supervisor Schantek – would like to thank all the veterans; also addressed citizen comments. Supervisor Sinnen – would also to thank veterans; looked into the Wal-Mart situation after the last meeting; looked into stop signs on Highway E & EA; also addressed citizen's comments.

Chairman Harbach – there was only one sewage dump and Mr. Stoner made reports to the DNR as required; also addressed citizen comments.

#### **Approve Appointment to Fire Commission**

Chairman Harbach personally spoke to each person who expressed an interest in the appointment the Fire Commission and is recommending Don Howland. He is a former member of the Kenosha Fire Department. The appointment is to fill a vacancy due to the resignation of Mrs. Meldahl with the term to expire in March of 2016.
