Citizen Comments

Ron Grimes, 3145 72nd Avenue, spoke regarding Majestic Project storm water run-off, flooding that occurred on his property and the high cost of flood insurance. Larry Harding, 445 8th Place, stated he was pleased with the selection of the interim fire chief. He asked for clarification of agenda items #9 & 11. He also questioned the need for incorporation. Glenn Fenske, 2930 72nd Avenue, stated his concerns regarding Majestic Project storm water run-off. Gloria Schiprio, 9920 88th Avenue, stated concerns over Majestic Project storm water run-off and asked if the road needed to be widened. John Sorensen, 524 9th Place, stated he was pleased with the proposed development and asked that the storm water run-off concerns be addressed early in the planning. Paulette Vanko, 301 6th Street, Racine, spoke regarding her application for an operators license. Carl Kirkorian, 502 9th Place, urged all to work together to promote development and reported on a Fox 6 News story regarding the North Shore Fire Department. He also stated insurance for firemen going up and the Town is making progress on cleaning up junk.

Supervisor's Comments

Sup. DeLuca thanked all for their comments and stated he is pleased with the conceptual of the industrial development. Supervisor Ress thanked John Sorensen for his offer to assume interim fire chief position. Sup. Schantek stated the Board will look at all issues raised with the proposed development including water run-off. She reminded the Board of the upcoming Pork Chop dinner. Sup. Sinnen reminded all of 911 tomorrow and the lives that were lost. He thanked Chief Krause for his many years of service to the Town. He also extended thanks to Nina Smith for her work on the EPIC Committee. Sup. Sinnen assured residents that the Board will listen to all concerns raised with the proposed development. Chairman Harbach stated the Board would listen to all flooding concerns with the proposed development. He also stated the Highway E Interceptor

project will allow the sewer moratorium to be lifted. Chairman Harbach also thanked John Sorensen and reviewed the list of Board priorities.
