#### **Citizen Comments**

Ron Grimes, 3145 72<sup>nd</sup> Avenue, provided a packet of information to the Board. The packet contained information regarding the Town website & organizational chart, goals & objectives and LED lighting. He also stated he supports the MIR Group Project. Carl Kirkorian, 502 9<sup>th</sup> Place, commented on the parking lot lights at Fire Station #2 & the Town Hall. He inquired if a grant could fund installation of LED bulbs. Mr. Kirkorian asked why the Public Works Superintendent receives overtime pay and the Fire Chief does not. Krista Reck, 6007 7<sup>th</sup> Street, stated her taxes had doubled in the past 2 years. She offered planning services to the Town. Ms. Reck also spoke about the Root-Pike WIN and its efforts for the Somers branch of the Pike River.
